MARITIME ECONOMICS AND CORPORATE FINANCE

The scientific school of maritime economics and corporate finance of ONMU has great history of formation and development, which has existed since 1930, when the department of social-political disciplines was created. During long time the school was represented by Prof. I. I. Herlich, Assoc. Prof. E. N. Shrabshtein, Assoc. Prof. N. K. Kruglenko, Assoc. Prof. M. O. Milyukov, Assoc. Prof. S. M. Topchiy, Assoc. Prof. A. A. Cherkesov-Tsibisov, Assoc. Prof. Y. P. Gubankov, Prof. V. I. Chekalovets, Prof. M. F. Serdyuk, Prof. V. G. Yakushenko, Prof. I. V. Morozova etc.

Modern market economy direction of the school was founded in the early 1990s by Prof. Dr. V. I. Chekalovets, honored worker of science and technics of Ukraine, excellent educational specialist, academic of Transport academy of Ukraine, author of more than 130 scientific and methodical publications, who was a scientific advisor of 16 philosophy doctors. Doctoral thesis by maritime economics were defenced by Prof. Dr. O. M. Kotlubay (2004), Prof. Dr. O. M. Kibik (2009), Prof. Dr. U. V. Shyriaieva (2009), Prof. Dr. V. V. Zhykharieva (2010) and other scientists. Since 2011 the school has been headed by academic of Transport academy of Ukraine Prof. Dr. V. V. Zhykharieva.

Nowadays the scientific school is represented by leading members of Economics and Finance Department of ONMU with research interests in maritime economics and finance: Prof. Dr. V. V. Zhykharieva (maritime investment management, corporate finance), L. V. Shyriaieva (financial management, economic intelligence, fixed assets reproduction), Prof. Dr. I. V. Poznanska (maritime transport policy, integration processes in maritime industry), Assoc. Prof. PhD L. P. Chyzh (economic financial security, business diagnostics), Assoc. Prof. S. V. Oneshko (cost management and controlling, International financial reporting standards, financial monitoring), Assoc. Prof. PhD N. V. Yarova (economics and management of the port industry), Assoc. Prof. PhD N. V. Khotyeyeva (finance security, management accounting and analysis), Assoc. Prof. PhD O. S. Vlasenko (labour economics, human resources management in maritime industry), Assoc. Prof. PhD O. V. Vorkunova (competitiveness in maritime industry, economic security), Assoc. Prof. PhD V. V. Baryshnikova (maritime economics, management and logistics) etc.

Professors take part in the scientific certification of economists in the field of maritime transport, oppose and review qualifying candidate and doctoral dissertations in economic specialties, and take part in the research work of the university.

In 2017–2019 research work was carried out within the framework of two state budget topics: "Methodological foundations of the formation of tariffs and fees in the port sector" and "Improving the theoretical foundations of the economic justification for the development of maritime transport enterprises". The main priorities of the scientific school are research of economic and financial problems of port enterprises, shipping companies, forwarding enterprises, shipping agencies, crewing companies and other enterprises of maritime transport.
